3. The **Leaflet Fee** is required of all entries that distribute leaflets to help cover the costs of clean up.
4. Throwing **candy** is permitted. Please throw the candy all the way to the curb area for safety.
5. The parade will end at **Alpine Elementary School**, 400 East 300 North.
